Περίληψη Πρόσκλησης:

Specific Challenge:

The uptake of R&I results created under the Framework Programme is important for the programme's success and is instrumental in contributing towards transformative impacts on the economy, society and policymaking.

To illustrate the wider socio-economic benefits of the EU investment in R&I and to encourage project beneficiaries to best manage and utilise their research results, the Commission awards on an annual basis a recognition prize for rewarding beneficiaries that have successfully demonstrated effective exploitation and uptake of their projects' R&I results.

In particular, five winners will be selected by the evaluation jury for their achievements. The prizes are monetary and each of the five winners will receive EUR 10.000. The prizes will be awarded during the Award Ceremony with a selected audience of high-level representatives and promoters of innovation in industry and public sector.

The specific rules of the contest will be published in 2019 by the European Commission[1], which will directly launch and manage the contest and award the prizes based on the judgement of independent experts.

Expected Impact:

With this award, the Commission aims to champion the uptake and use of EU funded project results, thus boosting their potential to achieve economic societal, and/or policy impacts. It is expected that the award, through showcasing best practices, will create role models and inspire R&I beneficiaries to use their research results to create value for the society at large.

Περίληψη Πρόσκλησης:	<p>Objective: The goal of the Individual Fellowships is to enhance the creative and innovative potential of experienced researchers, wishing to diversify their individual competence in terms of skill acquisition through advanced training, international and intersectoral mobility. Individual Fellowships provide opportunities to researchers of any nationality to acquire and transfer new knowledge and to work on research and innovation in Europe (EU Member States and Horizon 2020 Associated Countries) and beyond. The scheme particularly supports the return and (re)integration of European researchers from outside Europe and those who have previously worked here, as well as researchers displaced by conflict outside the EU and Horizon 2020 Associated Countries. It also promotes the career restart of individual researchers who show great potential.</p> <p>Scope: Support is foreseen for individual, trans-national fellowships awarded to the best or most promising researchers of any nationality, for employment in EU Member States or Horizon 2020 Associated Countries. It is based on an application made jointly by the researcher and the beneficiary in the academic or non-academic sectors. Only one proposal per individual researcher per call will be evaluated. Fellowships take the form of European Fellowships or Global Fellowships. European Fellowships are held in EU Member States or Horizon 2020 Associated Countries and are open to researchers either coming to Europe from any country in the world or moving within Europe. The researcher must comply with the rules of mobility in the country where the European Fellowship is held. Direct return to and long-term reintegration of researchers in Europe, including in their country of origin, is supported via a separate multi-disciplinary reintegration panel of the European Fellowships. For the reintegration panel, there must be direct mobility to the country of the beneficiary in Europe from a third country (compulsory national service and/or short stays such as holidays are not taken into account).</p>

Support to individuals to resume research in Europe after a career break, e.g. after parental leave or due to recent migration, is ensured via a separate multi-disciplinary career restart panel of the European Fellowships. To qualify for the career restart panel, researchers must not have been active in research for a continuous period of at least 12 months within the 18 months immediately prior to the deadline for submission.

Researchers seeking to work on research and innovation projects in an organisation from the non-academic sector will be supported via a separate multi-disciplinary society and enterprise panel of the European Fellowships. The objective of this panel is to facilitate career moves between the academic and non-academic sectors, to stimulate innovation, and to open attractive career opportunities for researchers outside academia.

The Widening Fellowships implemented through Work Programme part 15, Spreading Excellence and Widening Participation, provide specific support to researchers to undertake their fellowship in a widening country[1]. This will help spread excellence and close the still apparent research and innovation gap within Europe.

Global Fellowships are based on a secondment to a third country and a mandatory 12 month return period to a European host. The researcher must comply with the rules of mobility in the country where the Global Fellowship secondment takes place, not for the country of the return phase.

Researchers receiving an Individual Fellowship may opt to include a secondment phase in Europe, notably in the non-academic sector, within the overall duration of their fellowship. For a fellowship of 18 months or less, the secondment phase may last up to three months. For a fellowship of more than 18 months, the secondment phase may last up to six months. The secondment phase can be a single period or be divided into shorter mobility periods. The secondment should significantly add to the impact of the fellowship. In the Global Fellowships, such a secondment can also take place at the start of the action at the beneficiary or a partner organisation in Europe for a maximum of 3 months, allowing the researcher to spend time there before moving on to a partner organisation in a third country.

A Career Development Plan should be established jointly by the supervisor(s) and the researcher. In addition to research or innovation objectives, this plan comprises the researcher's training and career needs, including training on transferable skills, teaching, planning for publications and participation in conferences.

Researchers participating in the Individual Fellowships may opt to work part-time in order to pursue supplementary activities. These might include creating a company, or engaging in advanced studies not related to the MSCA grant. Any supplementary activities carried out part-time in parallel with the MSCA action must be agreed upon by the researcher and the beneficiary.

The objective is to bring innovations to the commercialization stage through:</p> <ol style="list-style-type: none">1. Licensing procedures for a new or existing company, or2. Financing a start-up company by venture capital, taking into consideration the nature of the idea, the potential of the market and the plan of the inventors. Innovations that will mature will be channeled to investors but also to social and environmental stakeholders, including social entrepreneurs, volunteers and non-profit organizations. <p>The program also seeks:</p> <ul style="list-style-type: none">-the viability of the idea at a technical and commercial level-the licensing/exploitation of intellectual property rights and their management-the ability to provide information on commercialization (e.g. budgeting) and the negotiation of the idea (e.g. contracting)-the development of a business plan in order to create a new product or new business. <p>-The "Proof of Concept" program is open to researchers and research companies based in Greece.</p> <p>The proposal is submitted only in the English language.</p> <p>The budget of the Proof of Concept program amounts up to € 500,000 per year for supporting 10 ideas (up to 50,000 for each project). Exceptionally, projects that require more maturing time will be able to extend to an additional 6-month period without increasing the economic requirements. Each "Proof of Concept" project will be continuously assessed and discontinued if the development of the concept is negatively assessed by the Advisory Board.</p> <p>Administrative costs that are mainly relevant to Advisory Board activities are estimated to 50.000 € annually. PSP will finance this kind of expenses.</p> <p>Proposal submission process and documents</p> <p>Applications are submitted by one person, the Project Manager, representing his research group/company, which is also the beneficiary.</p> <p>Submission is accepted only electronically.</p>
